SUBJECT: Receive Operational Update for February 2014

*This memo summarizes District activities for the month of February.*

Calls for service:

There were a total of 496 service calls in the month of February, with an average response time of 6:58 minutes. In the month of January the District ran 562 calls with an average response time of 7:04 minutes. In the calendar year of 2013, the District ran 6454 calls for service with an average response time of 7:08.

Looking at the response times by stations:

- **Station 52-John Muir Parkway, Brentwood**, had 153 calls in the month of February with an average response time of 6:11 minutes. In January there were a total of 174 calls with an average response time of 6:06 minutes. In the calendar year of 2013 the station ran 1857 calls for service with an average response time of 6:26.
- **Station 54-Downtown Brentwood**, had 98 calls in the month of February with an average response time of 6:06 minutes. In January there were a total of 106 calls with an average response time of 6:30 minutes. In the calendar year of 2013 the station ran 1336 calls for service with an average response time of 6:28.
- **Station 59-1685 Bixler Rd, Discovery Bay**, had 69 calls in the month of February with an average response time of 8:07 minutes. In January there were a total of 65 calls with an average response time of 8:05 minutes. In the calendar year of 2013 the station ran 774 calls for service with an average response time of 8:54.

- **Station 93 530 O'Hare Ave, Oakley**, had 133 calls in the month of February with an average response time of 6:47 minutes. In January there were a total of 157 calls with an average response time of 6:35 minutes. In the calendar year of 2013 the station ran 1752 calls for service with an average response time of 6:16.
- **Station 94-15 A St, Knightsen**, had 5 calls in the month of January with an average response time of 7:01 minutes. In January there were a total of 11 calls with an average response time of 7:44 minutes. In the calendar year of 2013 the station ran 176 calls for service with an average response time of 8:30.
- **Station 95- 3045 Ranch Ln, Bethel Island** (closed 7-1-2012), had 24 calls in the area of this closed station in the month of February with an average response time of 11:52 minutes. In the month of January there were 34 calls with an average response time of 11:29 minutes. In the calendar year of 2013 the District ran 355 calls for service in the station area with an average response time of 11:31.
- **Cal-Fire Station 16-Marsh Creek/Morgan Territory** had 14 calls in the month of February with an average response time of 12:27 minutes. In January there were a total of 14 calls with an average response time of 10:27 minutes. In the calendar year of 2013 the station ran 195 calls for service with an average response time of 9.25.

Auto aid:

In the month of February, the District received auto aid from Contra Costa County Fire 26 times, with them sending 30 engines. The District sent auto aid to Contra Costa County Fire 17 times providing them with 21 engines. During the month of January, Contra Costa County Fire came into the District 27 times with 32 engines and we responded into Contra Costa County Fire 21 times with 24 engines. In 2013, the District received auto aid from Contra Costa County Fire 345 times with them sending 476 engines. The District sent auto aid to Contra Costa County Fire a total of 198 times in 2012, sending 234 engines.
