**Re:** Operational Update May 2013

The staff report is to give you a summary of the activities throughout the District for the month of May.

On May 1, 2013 the district reopened station 54 in downtown Brentwood. This makes our current staffing model of five stations with 48 suppression personnel and 2 Administrative for total of 50 full-time employees.

Calls for service:

In reviewing the calls for service for the month of May there were a total of 547 calls with an average response time of 7:45 minutes. Comparing this to the month of April the District ran 507 calls with an average response time of 7:10 minutes. In the calendar year of 2012 the District ran 6303 calls for service with an average response time of 6:54.

Looking at the response times by stations:

- **Station 52-John Muir Parkway Brentwood**, had 125 calls in the month of May with an average response time of 6:32 minutes. In April there were a total of 137 calls with an average response time of 6:32 minutes. In the calendar year of 2012 the station ran 1748 calls for service with an average response time of 6:10.
- **Station 54-Downtown Brentwood**, had 128 calls in the month of May with an average response time of 6:06 minutes. In April there were a total of 119 calls with an average response time of 7:31 minutes. In the calendar year of 2012 the station ran 1345 calls for service with an average response time of 6:35.
- **Station 59-1685 Bixler Rd Discovery Bay**, had 59 calls in the month of April with an average response time of 10:10 minutes. In April there were a total of 63 calls with an average response time of 8:25 minutes. In the calendar year of 2012 the station ran 786 calls for service with an average response time of 8.44.

- **Station 93 530 O'Hare Ave Oakley**, had 136 calls in the month of May with an average response time of 6:09 minutes. In April there were a total of 150 calls with an average response time of 6:09 minutes. In the calendar year of 2012 the station ran 1801 calls for service with an average response time of 6:17.
- **Station 94-15 A St Knightsen**, had 19 calls in the month of May with an average response time of 10:02 minutes. In April there were a total of 10 calls with an average response time of 7:28 minutes. In the calendar year of 2012 the station ran 149 calls for service with an average response time of 9:12
- **Station 95- 3045 Ranch Ln Bethel Island** (closed 7-1-2012), had 30 calls in the month of May with an average response time of 12:26 minutes. In the month of April there were 11:17 calls with an average response time of 11:17 minutes. In the calendar year of 2012 the station ran 338 calls for service with an average response time of 9:34.
- **Cal-Fire Station 16-Marsh Creek Morgan Territory** had 13 calls in the month of May with an average response time of 9:14 minutes. In April there were a total of 11 calls with an average response time of 8:47 minutes. In the calendar year of 2012 the station ran 161 calls for service with an average response time of 9.00.

Auto aid:

In the month of May the District received auto aid from Contra Costa County Fire 38 times with them sending 50 engines. The District sent auto aid to Contra Costa County Fire 19 times providing them with 23 engines. During the month of April, Contra Costa County Fire came into the District 20 times with 28 engines and we responded into Contra Costa County Fire 13 times with 16 engines. In 2012 the District received auto aid from Contra Costa County Fire 389 times with them sending 518 engines. The District sent auto aid to Contra Costa County Fire a total of 167 times and 194 engines.
